### LARIA Updates

#### Update on LARIA Scotland – how we can enhance local evidence use?

LARIA Scotland, co-led by Nick Cassidy (Improvement Service), Erin Murray (Scottish Borders Council) and myself, Dave Blackbell (Scottish Policy & Research Exchange), has been busy this year exploring the question: *how can intermediary organisations and networks support enhanced evidence use in Scottish local policymaking?*

Our approach has been to explore this question in collaboration with other intermediary organisations and from the perspective of professionals on the 'front line' of producing, mobilising and using data and academic evidence. To do this, we've been working with Ian Dwyer from the Office of National Statistics Local Scotland, to run two networking and peer-learning workshops.

[The first was held on 11th June](#) and brought together ~110 people with  $\frac{2}{3}$  from the Scottish public sector and  $\frac{1}{3}$  from Scottish universities, with a panel of four experts from the public sector and academia. The second was a smaller, follow-on workshop on 20th August to make sense of the findings from the first, and brought together 13 of us who attended the initial workshop – mostly from Scottish councils.

Discussions across both events were rich and animating. We got a real sense from taking part – as well as from feedback and insights gathered – that events like these are energising, motivating and confidence building, that they play an important role in connecting people from across the sector to share learning and build solidarity, and that they capture important insights and implications about shared challenges and opportunities for action.

What did we learn about enhancing evidence use?

Well, much of the plenary discussion focused on a recognition that evidence and data don't speak for themselves – they need story-telling and clear narrative from practitioners able to hold and simplify the complexity of the challenges being addressed, and that often the value they provide is to enable the right follow-on questions to be asked. We also spent a lot of time discussing the importance of a clear and shared understanding of the desired outcomes that decisions seek to improve, aimed at improving the lives of real people (e.g. the [personal outcomes approach](#)). The systemic barriers to improving data quality and access was also a key theme, as was a concern for addressing bias often hidden within data and evidence, particularly when artificial intelligence is being used.

Based on the 233 insights captured from mentimeter during the first workshop (which provided us with digital 'sticky notes' of what people took away from breakout discussions), we undertook careful and AI-supported thematic analysis, and examined these in the follow-on workshop, which we hope to share the results of soon. As sneak peek, and in no particular order, the themes identified spoke to the importance of:

1. Strengthening collaboration, connection and trust
2. Combining different forms of evidence
3. Addressing bias
4. Mindful use of technology
5. Improving data quality, relevance and access
6. Politics, governance and how evidence is actually used by decision makers
7. Capacity building
8. Clarity on outcomes and impact
9. Using narratives that can communicate complexity
10. Community engagement

As next steps, we are working to identify and prioritise the implications of these insights for what intermediary organisations and networks can do to support improvements across these areas. An obvious takeaway is that events like these are important to keep running – which highlights the value of the LRIA network in being able to convene people with such important 'front line' expertise!
